0925am: Jennifer Driving Hawk had advised me that I had a phone call, as always I had asked her who it was, and Jennifer had advised me that it was Kevin Wright, so I had answered the call by stating "good morning this is Bob", Kevin had then asked me to come to his office as he needed to talk to me, so I had advised him that I would be right down

0927am: I had arrived at Kevin's office door and knocked on the door as it was closed, Kevin had then hollered come in, as I had entered Kevin's office, I had observed Kevin coming from behind his desk with a white coffee cup which had sage burning in it, Kevin had then offered me some smudge, and then Travis LaRoche who was sitting in a chair to my left as I entered Kevin's, and then to Cheryll Scott who was sitting to my right next to a TV, and then he had smudged himself and proceeded to walk around his desk, sat down in his chair and leaned back in his chair.

Kevin had then looked at me and had said, "first of all, there are a lot of rumors going on in the Community that I am supposed to fire you and your Security and replace you guys, and also fire a bunch of other people also. Then he had pointed to Travis LaRoche and had stated that he is my

personal Security Guard. Kevin then had continued talking to me, Kevin had again stated that he was not going to fire anybody and that the only ones he had wanted to get rid of was (Scott Jones, Dennis Hicks, Marshall Matz, and Tara Adamski.) Kevin had then stated that nobody else needed to worry about the rumors in the Community of people being fired.

Kevin had advised me that he is now the Chairman and that he is being recognized as the Chairman by the BIA, Aberdeen Area Office, Washington D.C and several of other areas. Kevin had then stated that he is tired of all the negativity in the community and that he wanted to start moving forward, then there was a knock on Kevin's office door, Kevin had asked me to open his door, at which time I did, and Sonny Ziegler had entered his office and stood to the east of Cheryl Scott, Sonny then advises me that they are not trying to strip anybody of their leases and that they are trying to get everybody's leases as walk in areas so the people can hunt and utilize the land, Sonny then advises he needs to leave as he has somebody waiting for him in his office, Sonny then leaves Kevin's office, shortly after Sonny leaves, there was another knock on Kevin's door, I opened the door and Robbie Men Many Horses enters the office and places himself

just to the East of Cheryl Scott.

Kevin then advised me that himself and Travis LaRocca were threatened by one of the Tondreas at the gas station this morning, Kevin then went on saying that he had terminated Scott Jones and that he is giving Scott 15 minutes to leave the building, at which time I had looked at the time on my cell phone and it read 0935am, Kevin had then stated if he don't leave or refuses to leave to call the Police Dept. for assistance in removing him from the building. Kevin had advised that, that was all he had to say, so I left his office.

0938am: At this time, I had advised Security Guards of what I was advised by Kevin, that Scott had 15 minutes to leave the building and if he does not leave then Law Enforcement is to be called to assist in his removal, then I had gone up to my office.

1014am: Spoke to Officer Batone who had advised me that there was nothing they can do without a Court Order to remove Scott, Batone then advised that Kevin would have to go fill out a complaint form and ask for a Court Order to remove Scott. Officer advised that he will do a walk through

of the building.

1024 AM: advised Robbie Her Many Horses of the Officer's statement, Robbie advised he would advise Kevin.

1026 AM: Spoke to Scott via phone

1055 AM: going to Council Meeting.
