1. Tribal Manager Update

Motion was made by Marvin Grassrope Sr. to approve a joint application to Treasury to receive a State Small Business Credit Initiative Funding. This motion was seconded by Chris Skunk. Motion carried with the vote being five members for, none opposing.

3. Lower Brule Gaming Commission

Motion was made by Chris Skunk to authorize Secretary Treasurer Marvin Grassrope Sr. to look for funds to hire an Executive Secretary for the Lower Brule Gaming Commission to comply with the National Indian Gaming Commission. This motion was seconded by Cody Russell. Motion carried with the vote being five members for, none opposing.

4. Shaun Grassel

5. South Dakota Housing Development

Motion was made by Marvin Grassrope Sr. to approve the South Dakota Housing for the Homeless Consortium to complete the 2023 Point-In-Time Count and Survey on the Lower Brule Sioux Tribe, pending review from the Tribal attorney. This motion was seconded by Chris Skunk.

Motion carried with the vote being five members for, none opposing.

6. Emily Flute

Motion made by Fely Goodface to follow the Lower Brule Constitution and Bylaws to use the petition by the people to banish Chief Judge Lorrie Miner. This motion was seconded by Marvin Grassrope Sr.

Marvin Grassrope Sr. withdrew his second.

Motion dies due to lack of a second.

7. Lower Brule Environmental Protection Office

Motion was made by Cody Russell to approve to accept P.L. 93-638 funds from the Bureau of Indian Affairs for Water Resources & Integrated Management Plan in the amount of \$75,000. This motion was seconded by Chris Skunk.

Motion carried with the vote being four members for, one abstaining (Fely Goodface).

Motion was made by Cody Russell to approve to accept P.L. 93-638 funds from the Bureau of Indian Affairs for Streamflow Gaging in the amount of \$34,570. This motion was seconded by Chris Skunk.

Motion carried with the vote being four members for, one abstaining (Fely Goodface).

Motion was made by Cody Russell to approve to accept P.L. 93-638 funds from the Bureau of Indian Affairs for the Great Plains Tribal Water Alliance in the amount of \$6,000. This motion was seconded by Chris Skunk.

Motion carried with the vote being four members for, one abstaining (Fely Goodface).
