4. Bear Butte Lease

Motion was made by John McCauley to renew the lease at Bear Butte for a period of ten years to Jim Jandreau and Clint Jandreau to include adding outside upkeep of the Sacred Hills area. This motion was seconded by Cody Russell.

5. South Dakota Medicaid Expansion

Motion was made by Cody Russell to support Medicaid Expansion through an Amendment to Article XXI, Constitution of South Dakota. This motion was seconded by John McCauley. Motion carried with the vote being five members for, none opposing.

6. Sandra Abdo Request

Motion was made by John McCauley to approve Sandra Abdo to run the concession stand for the 2022 Rodeo. This motion was seconded by Stephanie Bolman.

Motion carried with the vote being five members for, none opposing.

7. Black-Footed Ferret Project

Motion was made by Cody Russell to accept the Black-Footed Ferret Recovery Project, one-time PL 93-638 grant in the amount of \$49,932. This motion was seconded by Donovan Grassrope. Motion carried with the vote being five members for, none opposing.

Motion was made by Cody Russell to send a letter to the House Committee on Appropriations requesting an increase in ISEP funding for the Lower Brule School System. This motion was seconded by John McCauley.

Motion was made by John McCauley to approve Brian Wagner to continue with the Lower Brule Tribe's Health Insurance, he will pay his own premium costs. This motion was seconded by Marvin Grassrope Sr.

14. Lower Brule Cultural Resources Department

For the 2022 Annual Fair, the cooks have been selected and an advertisement will go out for security positions. The Lower Brule Farm has donated \$15,000 for supplies to repair the powwow grounds.

Motion was made by John McCauley to approve to donate one elk and one buffalo to the Annual 2022 Powwow from the Lower Brule Wildlife Department. This motion was seconded by Donovan Grassrope.

Motion carried with the vote being five members for, none opposing.

15. Tribal Planning Department

The Economic Development Administration (EDA) has tentatively awarded \$3,676,335 to fund the grocery store in Lower Brule.

The Red Tail Express bus bay is on schedule to be completed at the end of November 2022.

Motion was made by Cody Russell to approve Chairman Clyde J.R. Estes to sign the General Services Administration (GSA) lease amendment. This motion was seconded by John McCauley. Motion carried with the vote being five members for, none opposing.

16. Lower Brule Wildlife Program

The River Project is expected to be completed by December 2023.

Motion was made by Cody Russell to approve the Lower Brule Wildlife Department to submit a grant application through the National Fish and Wildlife Foundation. This motion was seconded by Donovan Grassrope.

Motion carried with the vote being five members for, none opposing.

17. Lower Brule Enrollment Committee

Motion was made by John McCauley to enter into a contract with Hanna Law Office, P.C. for legal services for ICWA and to authorize the Tribal Chairman to execute said contract on behalf of the Lower Brule Sioux Tribe. This motion was seconded by Cody Russell. Motion carried with the vote being five members for, none opposing.

Motion was made by John McCauley to enter into a contract with Donald M. McCarty for legal services and hereby authorize the Tribal Chairman to execute said contract on behalf of the Lower Brule Sioux Tribe.

Motion carried with the vote being four members for, one against (Stephanie Bolman).

Motion was made by John McCauley to authorize Chairman Clyde J.R. Estes to sign the contract for Lucky Seven Management Company for the Lower Brule Farm Corporation. This motion was seconded by Donovan Grassrope.

Motion carried with the vote being five members for, none opposing.

Motion was made by John McCauley to use Ferding Electric for the Annual 2022 Powwow for a cost of \$7,018. This motion was seconded by Cody Russell. Cody Russell withdrew his second. Motion was seconded by Donovan Grassrope.

Motion carried with the vote being five members for, none opposing.

Motion was made by John McCauley to hire Christopher Grassrope as the Youth Development Coordinator for the Lower Brule Teen Center. This motion was seconded by Stephanie Bolman. Motion carried with the vote being five members for, none opposing.

Motion was made by John McCauley to hire Tim Azure as the Tribal Manager for the Lower Brule Sioux Tribe. This motion was seconded by Cody Russell.

Motion carried with the vote being five members for, none opposing.
