5. School Status Report-October 2017

September 28, 2017

The School year is going well. We are nearing the end of our 1st quarter. The enrollment continues to grow. New teachers and programs are driving a very positive environment.

Curriculum and Instruction

• We have completed NWEA Map testing with all students. We reviewed NWEA reading and math data on Wednesday, September 13th, during our in-service. We set grade levels and individual goals with students. I have attracted data sheet showing Spring NWEA Map testing results. NWEA Map Testing is required by the BIE to be conducted three times per academic year as part of their accountability program. The data show progress for students progressing through our school annually: EXAMPLE

In large majority of grade levels, we have seen continued improvements annually.

- We will hold Parent-Teacher conferences on Thursday, October 19th.
- I have written for the Educational Enhancement Grant for approximately \$146,000. The focus of this plan is curriculum enhancements, interventions, and reliable technology to support these programs.
- The Lower Brule Science Research Institute will begin construction of the high tunnel hoop structure for its garden in the coming days. We have been working with Ms.
 Whitney Nordvold and Mr. Darrel Duvall from the USDA to assist in our gardening project and arranging contractors and garden beds once it is constructed. Our shop class will be involved again in constructing the beds.
- We have started our Agriculture Class, which is focused on poultry at this point (please see attached Sheet). We are excited to be providing our students these hands-on courses in the area of Career and Technical Education (CTE).

Enrollment and Staffing

- Lower Brule Schools enrollment is at 320 students.
 - October 1st, 2014 211 students
 - October 1^{st,} 2015 267 students
 - October 1st, 2016 293 students
 - October 1st, 2017 320 students
- We are pleased to see these increases in enrollment. With this comes some challenges, we have 35 students in grades KG, 9th, and 10th which has required us to hire some additional staff and get very creative with scheduling. Also, we have approximately 50 middle school students, we have shifted middle school classrooms to the portables for core content classes, creating a separation from the high school. We have staggered lunchtime for MS and HS students as we cannot accommodate all of the students at one time in the lunchroom. With this increased enrollment, we have seen an increase in the number of SPED students.
- Mr. Johnson is serving as the MS/HS Principal again this year, by making this appointment and not hiring a MS/HS Principal, there will be savings of an (estimated cost of MS/HS Principal \$65,000 plus fringe = \$100,000).

Activities

- Athletic Teams are having a successful fall. All teams are young comprised of many underclassmen. They are performing admirably. The football team currently stands with a 3-3 record. Our volleyball team has been very successes throughout the year. The volleyball teams and cross country teams will be competing this weekend at the Fall LBI.
- Basketball teams are hosting open gyms in preparation for the upcoming season.

Facilities

- We are hoping our facility funding arrives soon, as we still have many outstanding items that need to be addressed.
- Gymnasium floor will redone at the center circles as Wyoming Floors violated copyright
 as the Indian motif that was placed center court, which was copyrighted by Wyoming
 Indian School.

Lower Brule Sioux Tribe's 2017 Annual Fair and Rodeo Report

Greetings, members of the Kul Wicasa Oyate. The following is a summary of information provided by the many individuals directly involved in the Fair activities that are sponsored in part or in full by the Lower Brule Sioux Tribe.

Pow-Wow:

Despite the rain, dancers from places such as Garden Grove, CA; Ethete, WY; Anadarko, OK; Flagstaff, AZ; Granite Falls, MN; as well as many other towns in North and South Dakota came to participate in our pow wow activities. A total of 6 Lower Brule members placed in the dance competitions. This year's fair had well over 230 dancers and 30 drum groups. Attendance by dancers and visitors was significant; however was down somewhat from previous years due to the rain. The total payouts for dance contests, drum groups, and children's specials were in the sum of \$77,316. This does not include money that was returned from places that were not filled. The total amount received from venders was \$4,000. This is down from previous years due to no-shows because of weather. The kitchen served 5 meals for approximately 650 people- per meal. Total cost of the food and supplies amounted to \$13,331.00. There was no income received from gate fees as no admission was charged this year, again. The previously listed figures do not include cost of personnel such as crow's nest and cooks or other expenses such as electrical, fire extinguishers, cleanup crews, etc.

Annual Horse Races:

The initial budget for this year's races was in the total of \$13,500.00. This amount supported those involved in any way with staffing the race activities such as auctioneer, announcer, judges, outriders, runners, set up and cleanup crews, as well as race payouts. A total of \$5,500.00 collected from Calcutta percentages was returned to the Tribe which is a welcomed increase from previous year's returns.

Bull Bash, Ranch Rodeo and Regular Rodeo:

The budget for this year's rodeos totaled to the amount of \$28,500. This amount is completely paid out to the contractor for operational costs including stock and sub contractors, prize money, judges, barrier judges, book keepers, grounds cleanup crews, timers, arena help, pickup men, announcers, trucking /transportation costs, etc. A total of \$2,516.00 was returned to the Tribe, coming from Calcutta percentages. Any additional-operational costs associated with rodeo activities that were not supported in this budget are absorbed and fulfilled by the rodeo contractor. Donnie Moore would like to make mention of a special Tribal member who has in previous years always taken the time to lend a hand anywhere he could during the rodeo. The absence of Mr. Curt Middletent was greatly missed this year and Donnie & the entire community would like to send a heavenly "Thank you!" to Curt as he was called home to help out in the grand arena in he sky this past summer.

35th Annual Men's Softball Tournament:

The total amount budgeted for the tournament by the Tribe was in the amount of \$15,798 while the entry fees received from 16 teams totaled \$2,650. The total cost of the tournament including trophies, caps, supplies, prize money, umpires and their lodging, crow's nest expenses, announcer, book keepers, gophers, ASA fees, and cleanup crews was \$16,721 leaving \$1,727 having been returned back to the Tribe.

As you can see from the above figures provided, although it brings in additional revenue to our local economy; the Fair is not a profitable event for the Tribe. I want to thank our decades of previous leadership officials who have established our Fair time celebrations in the past as we continue to sponsor our annual fair and rodeo year after year. I'd like to give a special thanks to the Infrastructure Director and the Lower Brule Farm Corporation for working year round to accumulate and secure the funding to allow for this year's fair to take place. I would like to recognize Clair, pow wow staff & the Johnson Family; Trina & the Horse racing staff; Benny, Donnie & crew; Cody Russell & his crew as well as the many individuals involved in any way. Many people have given a great amount of hard work & dedication to the smooth operation of all of our fair activities. We would also like to recognize Partnership for success, Circles of Care, the Diabetes Program & their sponsors as well as the United For Youth Group comprised of community members who have created and sponsored activities for the youth of the community to take part in during our Fair time. I would also like to take a few moments to recognize all of the Tribal Members that have passed on within this past year to which the Annual Fair is dedicated. As we recognize the historical significance of our annual wacipi; we hope that our fair this year served as a unique opportunity for all of us to come together as a community and celebrate the beauty that encompasses the place that we call "Home".
