The Lower Brule Sioux Tribal Council meeting was held at the Tribal Administration Building on Wednesday July 5, 2023. The meeting was called to order by Chairman Clyde J.R. Estes at 10:07 am.

5. Lower Brule Health Department

Motion was made by Chris Skunk to approve and request "Mature Contract Status" for the following Indian Health Service P.L. 93-638 contracts: Mental Health, Community Health Representative, Alcoholism Abuse Prevention, Ambulance Service, Health Administration, and Patient Transportation. This motion was seconded by Cody Russell.

Motion carried with the vote being five members for, none opposing.

6. SDSU Request

Motion was made by Chris Skunk to approve South Dakota State University Extension to record drone footage at the following locations: Lower Brule High School, Partnership for Success, Tribal Headquarters, Wata Onazin Recreation Area, and Hilltop Baptist Church. This motion was seconded by Jewel Jandreau.

7. Lower Brule Anti-Bullying Movement

Motion was made by Fely Goodface to formally recognize the Lower Brule Anti-Bullying Movement as a community-based volunteer group. This motion was seconded by Jewel Jandreau.

8. Summer Works Program

Motion was made by Fely Goodface to approve the Summer Works Program to begin July 19, 2023 through August 15, 2023 for youth and July 19 through August 29, 2023 for adults. This motion was seconded by Chris Skunk.

Motion was made by Lewis Grassrope to approve Cody Russell as the U.S. Army Corps of Engineers Missouri River Recovery Implementation Committee (MRRIC) representative. This motion was seconded by Chris Skunk.

Motion carried with the vote being four members for, one abstaining (Fely Goodface).

Vocational Rehabilitation Program

Motion was made by Chris Skunk to approve the director's recommendation to hire Marlo Langdeau for the position of Youth Case Manager for the Vocational Rehabilitation Program. This motion was seconded by Cody Russell.
