3. Lower Day School Update

December, 2017

We are coming to the end of our fall term. We hope everyone had a wonderful Thanksgiving. We are thankful for the unseasonably warm weather. This report will highlight a few of the Educational activities at Lower Brule Schools.

Curriculum and Instruction

- We have begun the process with AdvancEd and COSA to seek accreditation. This
 process will begin this year and I will keep you posted on the progress. This accreditation
 will allow us flexibility with SD DOE e.g. not having to engage with state assessments as
 we already partake in BIE required NWEA Map Testing.
- Educational Enhancement Grant for approximately \$146,000. The focus of this plan is curriculum enhancements, interventions and reliable technology to support these programs. Will be reviewed for approval this month by BIE.
- Mr. Shroyer and I participated in a BIE conference call mid-November. On this call many
 educational items were discussed. An important item was that Dr. Longie stated that
 tribally controlled schools do not have to participate with the Native Star Program.
 AdvancEd/COSA will provide with a school improvement platform to met some of their
 requirements.
- We are still awaiting orders for classroom supplies, technology (hardware and software) this has created some challenges for our facility and slowed the learning process for our students.
- Last Day of School is December 12th, prior to the holiday break. We are considering a lunch meal on December 19th, 20th, 21st during the break to assist some of our students with meals.

Enrollment and Staffing

- Enrollment at Lower Brule Schools is currently approximately 315 students K-12.
- We have hired an additional Elementary teacher for 2nd grade due to 25 students, with a high number of SPED students. Jessica Brownell hails from Pukwana, a recent graduate from USD with a dual major in Elementary education and Special Education.

Activities

- Elementary School Christmas Program-will be held Friday, December 8th at 1 PM at the Elementary School. We would welcome your attendance.
- Traditional Games- Mr. Prado attended a workshop in Rapid City for traditional games. He is not incorporating those into his P.E. classes.
- First Tee Golf Program This is a new golf program being instituted at the Elementary School. This will provide our students with golf equipment and golf education through P.E.
- Basketball teams and Wrestling teams are preparing for the upcoming seasons. The first basketball game is December 8th in Marty and the following week is LNI.
- Archery, Hand Games, Art, and Knowledge Bowl teams are busily preparing for LNI.
- Community Thanksgiving Meal and Lakota Bingo was a great success for our community. The culinary Arts and Hospitality classes served approximately 200 community members. The Lakota studies conducted Lakota Bingo. All food was provided by Partnerships with Native Americans.
- Veteran's Day Program- was a great success hosted by our Speech class. Our students showed great support to our veterans.

Facilities

- We are thankful for some movement on facility needs. We hope that we will see continued support ahead. There are still many outstanding issues to be resolved.
- Gymnasium floor is fully completed.
